

Pat Barbosky, January '71, is working as a legal secretary in sunny Tucson, Arizona.


Elizabeth Herten, June '71, recently graduated from Bowling Green State University with a degree in Secondary Education.

RENOVATIONS at JMH




As part of the Alumni Newsletter's continuing series "What's Happening at John Marshall Today," we present a look at the transition of the old gymnasium into the Senior Cafeteria and Wood Shop.

This view from the gym balcony shows where the Lawyers used to host basketball and wrestling contests. In addition, the gym was used for boys' physical education classes.

Thanks to the one million dollar contract let by the Cleveland Board of Education, the upper half of the gym was converted to a combination Senior Lounge, Cafeteria, and Study Hall.

Work started in February of 1972 and was completed in June of 1973. The entire facility is air conditioned.



The lower level, which was the gymnasium floor, is now the Wood Shop. Equipment that was housed in the second floor shop has been moved to the new facility.






ORGANIZATIONAL
