

THE END OF AN ERA

Lee B. Bauer (1900-1985)

"We are all more alike than different. You respect people on the basis of what they can do, but at the same time you aim to put yourself out for other people who need help. Good human relation is part of growing up and helping others to grow up."

With that philosophy it is easy to see why Mr. Bauer was appointed as Assistant to the Superintendent for Human Relations following his tenure at John Marshall in 1965.



Mr. Bauer entered his first teaching assignment when he was 18 years old, and he was made principal the following year in his native Brown County, Ohio. He taught at Eagle Township High School and was principal at Lewis Township Consolidated School in Higginsport.

During this time, he was working on his bachelor's degree by attending summer school. His education had begun in a one room school house. "I was a farm boy and had to get my education in pieces," he had said.

Mr. Bauer was principal of Medina High School from 1920 to 1922 and in 1923 received a degree in education. In 1927 he received a master's degree from Ohio State.

He joined the Cleveland school system in 1928 and was assigned to teach at West Tech. In 1932 he became the head of the social studies deptment and an assistant principal at James Ford Rhodes High School. From 1935 to 1942 he was principal of William Dean Howells Junior High School, and was then appointed as director of the systems Adult Education Program.

He was named principal of John Marshall in 1946. Later he had remarked, "What an honor it was to sign the diplomas of over 10,000 of the finest young people in America."

Mr. Bauer had been a teacher and Sunday School Superintendent at West Park United Church of Christ where he had been a member since 1937. He is survived by his wife Edna, a son, daughter, seven grandchildren and eight great grandchildren.

A MEMORABLE DAY

In May of this year I had the good fortune to accompany Joy Smith (6/59) and Mary Gensler, former Home Economics Department Chair, to Mr. Bauer's home. At that time we informed him of the plaque and scholarship fund to be permanently established in his honor. He was very moved that so many people would participate in this venture. The next two hours passed quickly while we listened to a man with a few of the infirmities of age but no less brilliant than he had ever been. Although he himself had never earned less than an A, his real brilliance was seen in his never ending questions and concern about his former students and staff — he asked about and remembered so many of you that it left us amazed.

Ironically, the plaque, that we had hoped he would be able to see, arrived on the day that he passed away. Nevertheless, you can all take a measure of pride in making it possible.

REUNIONS

Probably the most often asked question that comes to the Alumni office is, "Are there any plans for a reunion for my class? Some classes have had several — often planned by the same committee. Other classes have never had a reunion. A common practice has been to combine the efforts of a January and June class for a single reunion. This is not a hard and fast rule, however, as many classes have opted for individual reunions. While many classes meet every five years, they can be held at any time. The 1952 class, for example, held a 33-1/3 year reunion in October of this year.

Many people are quick to ask why their class has never had a reunion. Others are quick to complain if the reunion is (a) too expensive, (b) too far away, (c) too soon, (d) too cheap, (e) too large, (f) too small, (g) all of the above.

I suppose those people exist everywhere, and they certainly have never been involved in planning a reunion. Just try to remember that the main objective is not gourmet cuisine, top flight entertainment, or lavish surroundings. The purpose is to meet with old friends and relive some pleasant memories.

Many times, before graduation, classes elect alumni officers for the specific purpose of planning reunions. In other cases the senior class officers take on the formidable task. But, for the most part, the planning is simply done by people interested in having a reunion.

The most difficult task of any committee is to ascertain the present addresses of class members. This is where the Alumni Office can help. NO WITCH HUNT IN THIS SALEM!

Occasionally newspapers do have some positive stories. For example: Plain Dealer, April 10, 1986, Salem, OH. "Alumni Prove They Learned Something About Generosity." The highlights of this article were that the Salem High School Alumni Association, which was founded in 1882, has its own downtown office and part time executive officer. They have a computerized listing of 8,500 graduates and an annual newsletter which produces \$6,000 a year in donations. Most astonishing is their endowment fund which is worth \$1.25 million. Most of that fund came from two large estates which were left to the association. The fund provides scholarships to any senior with at least a B+ average. In 1986 40 seniors in a class of 220 will share \$100,000. These scholarships range from \$1,000 to \$6,000.

These are impressive statistics and certainly could be held up as a worthy set of goals. With that as a standard, I think we are headed in the right direction. Our semi-annual newsletter is mailed to over 15,000 alumni, and our scholarship fund continues to grow. That's not too bad for an organization that is only 13 years old. John Marshall High School is continually grateful for your ever increasing support.

CLEARING THE AIR

This is a most difficult article for me to write, but I think it is necessary to eliminate some questions which have arisen and to dispel some nagging fears that you may have. One of the areas of concern deals with the Alumni Association and the other with the school.

The Alumni Association was started in 1973 by Paul Gruber (6/69) whose recent indictment by the Cuyahoga County Grand Jury prompted this article. The reasons for the establishment of the association are unclear, but the organization grew beyond anyone's original expectations. Late in 1983, The Alumni Trustees instituted a number of new management and financial controls. These were unsatisfactory to Gruber, and he resigned as of 1/1/84 and has not been affiliated with the Alumni Association in any way since that time.

The second area of concern involves the school system in general and John Marshall in particular. Those of you who are in an area where the media covers Cleveland Public Schools know what I'm talking about. In the past eight years we have had nine superintendents, busing, teacher strikes, financial turmoil and just about everything else. I can't speak for the rest of the system, but John Marshall is blessed with a highly trained and experienced staff who simply carry out the day to day business of education and largely ignore the controversy that continually embroils headquarters. Make no mistake, John Marshall is not the same school today that it was when you were here. After all, the only thing which remains constant is change itself. Nevertheless, our top graduates today would be able to compete with those of the past and those of any other school system today. We look forward to seeing these young people assume their positions of leadership in tomorrow's society as you have done in yours.




